

# Beko Stress-Free Cleaning Dishwasher Fairy Promotion Terms and Conditions

1. Instructions on how to claim and the gifts form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions. Offer not valid in conjunction with any other offer.
2. Claims are only open to Australian residents.
3. Claimants under 18 years old must have parental/guardian approval to claim and further, the parent/guardian of the claimant must read and consent to these Terms and Conditions.
4. Employees (and their immediate families) of the Promoter, participating retailers and agencies associated with this promotion are ineligible to claim.
