General Terms	<ol style="list-style-type: none"> 1. The standard terms and conditions of sale of the Participating Store apply to all Eligible Product purchased by an Eligible Customer. 2. The Gift with Purchase is not transferable, exchangeable or redeemable for cash. Gift with Purchase values are in Australian dollars. If a Gift with Purchase is unavailable for any reason, the Promoter, in its sole discretion, reserves the right to substitute the Gift with Purchase with a gift to the equal value and/or specification. 3. This Promotion is not open to companies, businesses, organisations, body corporate bodies, groups, trade customers or resellers or distributors of products or anyone acting on their behalf. Excludes projects and commercial orders. 4. Proof of payment receipts must clearly specify the Participating Store, the Eligible Product purchased, the purchase price of the Eligible Product and that the purchase was made during the Promotional Period. Eligible Customers must retain their proof of purchase in the event that the Promoter requests further verification of the receipt. 5.
